  - President Report The report is as follow:
    - ✓ Unity In Our Community meeting scheduled for Saturday, July 13<sup>th</sup> is cancelled.
    - ✓ Campbell Avenue youth recognition awards will be presented to seven (7) youths at the block party on August 3<sup>rd</sup>. Each youth will receive a certificate and \$25 gift card from the block club.
    - ✓ Backpacks/School Supplies/Water Bottles will be given out to the youths attending our block party on August 3<sup>rd</sup>. We have a total of 60.
    - ✓ Other Items A motion to approve the block party was not on the July 11<sup>th</sup> City Council meeting agenda. The President will request it be placed on the next City Council meeting scheduled for July 25<sup>th</sup> for approval.

- Treasurers' Report Due to the absence of the Treasurer and Assistant Treasurer, the report was tabled.
- Standing Committee Reports
  - ✓ Event Committee The Chair/Co-Chair discussed the following events:
    - The 3<sup>rd</sup> Annual "Unity In Our Community Back-To-School With A Purpose" block party plans were submitted to the Board. The total estimated cost will be \$2,024.00. We were fortunate to have several donations this year from businesses and individuals (Pete's Market, Impersonator, Gaming Truck, J.J. Fish & Chicken, chips, freeze pops). The block party schedule was discussed, finalized and approved by the Board. The final schedule to be distributed to residents throughout our block and side streets (Lucas, Harding, Breclaw, Stewart, and George).
    - The Committee is currently looking for a location to host our 2024 Holiday Winter Social Event.
  - ✓ Outreach Committee The Chair reported the following upcoming workshops:
    - Free Tto Be Just Me Saturday, July 20<sup>th</sup>, 11am 2pm, Sandridge Fitness Community Center. An interactive discussion and presentation by RUSH Substance Use Disorder, Center of Excellence, with our youth on self-esteem, peer pressure, self-identity, substance use (family, friends), etc.
    - ➤ Be a Winner For Job Opportunities Saturday, August 24<sup>th</sup>, Calumet City Public Library. Panel discussion with managers/supervisors from federal government, city/local agency, corporate office, and youth organization.     - Legal Services The Chair is looking into having Legal Shield come in to put on a presentation on legal matters. Contacted representative and awaiting response in order to schedule a possible date in September.
  - ✓ Educatonal Committee Unfortunately, we did not receive any applications/essays from graduating seniors for the Robert F. McGee Scholarship. The Chair will work with the Mayor and Director, Calumet City Youth Development Services to plan how to present/promote to the high schools in the Southland for 2025. The funds raised for the scholarship this year will be placed in reserved in our bank account.
