Block Club Activities

- ✓ Robert F. McGee Scholarship – awarded \$1,000 to a graduating high school senior attending Roosevelt University; Chicago College of Performing Arts.

- ✓ Open Closet Extravaganza – participated in the City of Calumet City’s Spring & Summer event; donated bags of clothing, shoes, men suits, 7 boxes of canned and boxed foods; setup resource table in library.
- ✓ 4<sup>th</sup> Annual Block Club Party Celebration – hosted block party with kids’ activities, entertainment, game prizes, food, drink and awarded 2 Certificates of Achievements to the Class of 2025 H.S. graduates w/Visa gift card.

#### Unity In Our Community Nonprofit Charitable Organization Activities

- ✓ Feed Someone In Need – In April, prepared/packed/delivered 30 homecooked meals to individuals homeless temporarily residing in a hotel. In June, delivered 120 Hormel Compleats Variety Dinners and Welch’s juices to South Suburban PADS Chicago Heights office. The meals will be delivered to 4 hotels with individuals/families temporarily homeless in the southland.
- ✓ Kickin’ It With Kendra hosted a Faith & Fitness session at the South Holland Community Center for Calumet City’s Senior Citizen Advisory Committee members.
- ✓ It’s a Pickaway Yard Giveaway – Variety of items donated (household, appliance, clothing, shoes, family board games, skates, bikes, rugs, etc); all FREE to residents in the community.
- ✓ Youth Employment Training Seminar – Hosted 2 sessions in April & August at the City of Calumet City’s public library. We had a total 34 youths in attendance.
- ✓ Provided clothing to a senior citizen in the 1<sup>st</sup> Ward who requested clothing to wear to church (2 skirt suits, dresses & pants).
- ✓ Diapers – Donated 6 bags of diapers to our partner Kickin’ It With Kendra for mothers in need.
- ✓ Holiday Giving – Distributed to Sunrize Restaurant 15 new coats and hat sets for adults and children to the City of Calumet City holiday drive and 15 new coats, hat sets, shoes, men shirts, women pants and men and women suits to Free-N-Deed food pantry’s holiday event in Dolton, IL.
